**DOG LICENSE INSTRUCTIONS**

**OWNER'S INSTRUCTIONS**

1. Check license for accuracy and completeness. Enter any corrections in ink before mailing.
2. Don't forget to sign form before mailing.
3. Required documents
  - A. Proof of rabies vaccination is required in all counties as required by public health law#2145. Proof of rabies vaccination must extend into the new licensing period.
  - B. Proof of spaying or neutering required unless already on file where application is made; and,
  - C. Proof of fee exemption for guide dog, hearing dog, police work dog, war dog or service dog.
4. Make check payable to Town of Whitehall. Enclose a self-addressed stamped envelope. A validated license will be returned to you.
5. If you no longer live in the Town of Whitehall, please license your dog with the municipality where you live now.
6. FAILURE TO RENEW LICENSE IS AGAINST THE LAW AND COULD MEAN A FINE.
7. IF YOU NO LONGER HARBOR THE DOG, PLEASE LIST REASON WHY ON FRONT OF FORM OR IN A LETTER STATING REASON (death of dog, lost or stolen, transfer of ownership).
8. Please return dog tag if deceased or transfer of ownership.

Remember to keep your dog on a leash at all times. Dog license and rabies tags should always be on dog in case needed for identification. Found dogs without identification will be transferred to DCO. Nancy Quell and held there. If there is no identification we can only harbor the dog for a few days. Owner will be responsible for all charges.
