WHEREAS, the Town Board of the Town of Whitehall has received the 2024 Tentative Budget at the September 13, 2023 Board Meeting; and

WHERE AS, the Town Board of the Town of Whitehall reviewed the 2024 tentative budget at a workshop on October 3, 2023 and has recommended changes; and

WHERE AS, the Town Board of the Town of Whitehall hereby adopt the Tentative Budget as herewith to the Town Clerk as the Preliminary Budget for the fiscal year 2024; and

WHERE AS, the Town Board of the Town of Whitehall hereby authorizes the scheduling of a Public Hearing in-regard to the Preliminary Budget for the fiscal year 2024; and

WHERE AS, that said Public Hearing shall be held on October 18, 2024 at the Town Municipal Building, 57 Skenesborough Drive, Whitehall, NY 12887 at 7 PM, at which time all interested persons shall be heard; and

BE IT FURTHER RESOLVED, that the proposed salaries of the following officials for fiscal year 2024 shall be advertised, as required by Section 108 of Town Law of the State of New York, as follows in said notice:
