Mobile Home/Trailer Camper Application
Check List

- 1) Application for mobile home/trailer camper must be completed and signed by Enforcement Officer and Town Supervisor.
- 2) Short Environmental Assessment Form must be completed.
- 3) Accompanying fee of \$100.00 must be accompanied with form. Check to be made out to Town of Whitehall.
- 4) A plan drawn to scale showing lot boundaries and dimensions, location of mobile home and other structures, and location of, or plan for proposed water supply and sewage disposal system.
- 5) A copy of the deed.

Along with the mobile home/trailer camper application, a building permit must be filed with Washington County.

- 1) After entire permit is filled out, form LRCC#1 must be signed by Enforcement Officer or Town Supervisor.
- 2) Building application must be completed and submitted to Washington County for approval. WE MUST HAVE A COPY OF BUILDING PERMIT IN THIS OFFICE AND NEW CONSTRUCTION QUESTIONNAIRE FOR TOWN ASSESSOR.
- 3) Any questions on building permit you may call the Department of Code Enforcement at Washington County at 746-2150.
