Trustee Watson reported that CHPE have been given a list of supplies needed to be on hand before digging in the Village. The 14" waterline has a small leak which is being monitored. He has talked with Granville regarding their UV Disinfection system. Clark Wilkinson has not responded as to why the contractor has not started on the waterline replacement under the Poultney Street bridge. Trustee Watson reported that we received the bill from the company that NYS Dept. of Environmental Conservation sent to clean up after the vac truck spill totaling \$44,000.00. This has been submitted to the Village's Insurance company.

Trustee Norton reported that the skid of filters at the Water Treatment Plant needs to be replaced. The current price that was received is \$170,000.00 and we only have \$150,000.00 in the capital account for this.

Trustee LaChapelle stated that Skene Manor would like to erect a sign in the parking lot on Main Street. He was told to have Skene Manor submit this request in writing to the Board.

Mayor Eagan stated that John Huggins of Glens Falls Hospital was suppose to give a presentation on grants for Safe Streets but did not attend this meeting due to the bad weather.

Trustee Putorti stated that it is a bad situation at his neighbor's yard. There are car parts, dismantled vehicles and other garbage in the yard. Chief Buxton reported that NYS DEC stated that there were no violations at this address. Chief Buxton was told that the situation would fall under NYS Dept. of Transportation and they have not been responsive to his calls to investigate. Trustee Norton feels that the Police Department could do more regarding this. The Village's Nuisance Law needs to be enforced.
