

Budget Officer Joel Carpenter discussed with the Town Board different a health insurance option for the Town for 2024 with the Union. The Town's current HMO is \$6,150 monthly; proposed EMO ^&7,000.00; union proposal is \$5,520 which includes all out-of-pocket costs (not including eye/dental coverage). The down side is that all Town employees would be required to participate in the plan even if employee is on spouse's plan, they would still be required to enroll in single plan at their expense. Highway employee Lukas Longtin likes the plan but would like to the difference in cost go into salary to get them up to what other towns are at. Attorney Seller-Ryan suggested the Town Board go into executive session to discuss the Union Contract.

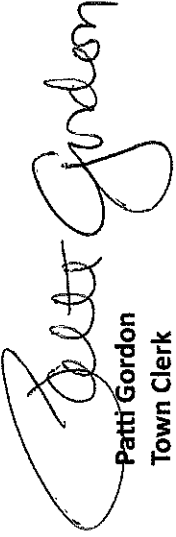
